
It is also observed that many shareholders have not register/updated their bank details (NECS/IFSC information) in the Demat account due to which Company is unable to credit dividend directly in to your Bank Account. Registration of NECS/IFSC information in your Demat account will facilitate remittance of dividend directly into your bank account through electronic mode. This eliminates the possibility of loss of dividend warrant in transit and minimising risk of misappropriation. Further, in respect of your shares held in electronic form in your Demat account, it is mandatory not only to update bank account details with the depository participant but also details of your email id and mobile number so that information relating to your investments can be disseminated to you seamlessly.

As a service to our shareholders, the format of providing such information is enclosed herewith. You are requested to complete the same and hand it over along with supporting documents to the Depository Participant with whom you maintain your Demat account and in case of you hold the shares in physical form we request you to send the enclosed form at the Company's Share Registrar and Transfer Agent (RTA) viz.
